In the reference of the above subject we have to say that –

1. The expiry date of the validity of our FDR'S were 30.07.2017 but we renewed both the FDR'S in the same date which is valid up to 30.07.2022. (copy enclosed, Annexure:- 1 and 2)
2. The FDR of Rs.5,00,000/-(Five Lakh) as Endowment fund and FDR of Rs.3,00,000/-(Three Lakh) as reserve fund is maintained from time of Recognition of the institution i.e. from 30.07.2012 and after renewal it is Valid up to 30.07.2022, having same account No- 32455753175, and 32455751383 respectively. "Clarification and willingness for compliance of the NCTE (Recognition Norms and Procedure) Regulation 2014 and its implementation by all the Existing Teacher training institutions" we have maintained the Endowment Fund and Reserve Fund in the manner prescribed for the existing course. So, we have maintained two FDR'S for Rs.8, 00,000 (Eight Lakh) for existing programme B.Ed. and for another Course D.El.Ed. We had applied and got recognition we obtained two another FDR'S for Rs.12, 00,000/- (Twelve Lakh) as said. (Annexure:- 3,4,5)
